## **WHO IS INFRAGARD**

#### **WHAT IS CYBER CAMP 2022**

Cyber Camp 2022 is a summer camp in which high school students will have the opportunity to learn about digital forensics and cyber security. Students will also gain practical skills through instruction by experienced security and information technology (IT) professionals, and hands-on exercises. The Camp will provide instruction in Linux bash command line, forensically process and manage digital information, and ethical responsibilities in cybersecurity.

#### WHEN IS CYBER CAMP 2022

The Cyber Camp is one week from Monday, July 18, 2022 through Friday, July 22, 2022 from 9am-4pm, with a 1-hour break for lunch.

### **WHO CAN ATTEND**

High school students who are rising freshmen through graduating seniors who have a basic understanding of computers (Windows OS) and a strong passion to understand and learn about cyber security. Experience with command line is helpful but not required.

- Linux operating system from the command line
- How to process and manage digital information
- How to forensically process and manage digital information
- Ethical responsibilities in cyber security
